





Housing Authority Rental Assistance Programs

87% of HACSM's 5,000+ vouchers assist Extremely Low Income and formerly homeless households

Rental assistance awards over previous 24 months

- Received and leased-up 222 Emergency Housing Vouchers for homeless households
- Received and now leasing-up 71 Mainstream Vouchers for homeless and at-risk households
- 15 Foster Youth Independence Vouchers just received for homeless and atrisk former foster youth
- 37 new Permanent Supportive Housing rental assistance certificates just awarded for chronically homeless individuals
 - = 345 homeless or at-risk households quickly housed

County Housing Voucher Program

In March 2023, the Board of Supervisors approved \$8 million in Measure K funding for a new County Housing Voucher Program.

Program Goals:

- Keep rents deeply affordable for 100-150 formerly homeless households.
- Support housing retention by providing access to intensive supportive services.

County Housing Voucher Program:

- Program limits rents to 30% of tenant's gross income.
- Tenants have access to on-site intensive support services free of charge.
- Ongoing 15-year program.
- 2023 Launch







Homekey Housing Opportunities



Homekey Hotel: Shores Landing

- Shores Landing is located in Redwood City
- County purchased Marriott TownePlace Suites in December 2020
- Converted the property into 95 units of supportive housing for extremely low-income homeless seniors
- Property fully occupied by June 2021
- County partners: MidPen (operator); Mental Health Association of San Mateo County (resident services provider)
- Purchase price: \$29,250,000
- Homekey Award: \$20,356,500
- County Match (CARES Act): \$11,602,000
- Property Renovation/Expansion (CDBG-CV): \$4,735,791



Homekey Hotel: Casa Esperanza

- Located in Redwood City
- Purchased Comfort Inn in April 2022
- Converted into 51 units of permanent supportive housing for extremely low income and homeless adults
- Fully occupied by February 2023
- County partners: Alta Housing (operator); San Mateo County Department of Public Works (general contractor); Mental Health Association of San Mateo (resident service provider)
- Purchase Price: \$17,000,000
- Homekey Award: \$14,468,323
- County Match (ARPA): \$13,266,000



Homekey Hotel: Move-In Day for Octavio and Raymunda

Story of a Mother and Son

- Octavio lost his home 5 years ago, when he lost his wife and fell into dependency
- Found temporary housing in a small RV parked in a RV parking lot
- His 87 year old mother, Raymunda, also moved into the RV
- County's Coordinated Entry System (CES) offered Octavio and Raymunda a unit at Casa Esperanza Apartments

Homekey Hotel: Casa Esperanza

On-site resident support at Casa Esperanza has helped Octavio to maintain sobriety and search for jobs to support himself and his mother

Raymunda benefits from living in a unit that is ADA accessible

On-site resident support has helped Raymunda access medical referrals and transportation assistance
